# OREGON HIGH DESERT CLASSICS VENDOR TERMS & CONDITIONS 2022

CLASSIC I: JULY 20 - 24 | CLASSIC II: JULY 27 - 31

**Operational Hours:** Business hours for the OHDC Vendor Village are Wednesday - Sunday from 10:00 AM - 5:00 PM, during the two week event. You are required to be open these minimum days & hours. **You are welcome to be open during the Monday & Tuesday before the show, at your own discretion, please inform the Event Coordinator of your decision.**

Vendor Set Up Day will occur Sunday, July 17th from 9:00 AM to 5:00 PM. Please call to schedule an appointed set up time.

## Vendor Regulations:

- Vehicles are NOT permitted in the OHDC Vendor Village between the hours of 7:30 AM and 5:00 PM during the show.
- You or your business will provide all the materials for your own booth set up. J Bar J Youth Services and/or OHDC will not supply any materials, including but not limited to: tents, water hoses, extension cords, ladders, or supplies of any kind.
- Food Vendors and Enclosed Trailers are **REQUIRED** to have a working fire extinguisher in their booth at ALL TIMES.

**Insurance Coverage:** Provide a copy of a current Certification of Liability Insurance naming J Bar J Youth Services as additional insured.

**Food Vendor:** Provide a current Food Vendor License. All food service, no matter how temporary must meet food safety regulations to protect the public from possible food-borne illness.

**Promotions, Marketing, & Advertising:** Support at-risk youth and promote your business with an OHDC sponsorship through cash, gift certificates, or product donation for horse show prizes and awards. Sponsor benefits include promotion through ring announcements, opportunity to add items to the trainer bags, and flyers in the show office.

Advertising in our Prize List - list of classes & events distributed digitally to all exhibitors; or our Show Guide - publication available during the event and distributed in local media publications prior to the show. Please mark the appropriate box on the application if you wish to receive further information regarding any of these areas.

Your business will be listed on the Vendors page on the OHDC website with a link back to your website.

**Vendor selection and approval is at the sole discretion J Bar J Youth Services and the Oregon High Desert Classics (OHDC) management staff. If your application is approved the location of your booth will be determined by management. Selected vendors will be required to comply with and sign J Bar J Youth Services/OHDC Vendor Contract as a condition of participating at our event.**
