Operational Hours: Wednesday – Saturday 11 a.m. - 5 p.m. and Sunday 11 a.m. - 3 p.m. These are the minimum days & hours you are required to be open. If you would like to be open before the shows start, please list your days of operation on the Vendor Application.

Set up: Sunday, July 14 from 9 a.m. - 5 p.m. Please list your preferred time for set up on your Vendor Application. The Events Coordinator will follow up with a scheduled time.

Vendor Regulations:

- You must provide all the materials for your booth set up. J Bar J and/or OHDC will not provide any materials, including but not limited to tents, extension cords, water hoses, ladders, or supplies of any kind.
- Food Vendors and enclosed trailers are **required** to have a working fire extinguisher in their booth **at all times**.
- Vehicles are **NOT** permitted in the Vendor Village between the hours of 7:30 a.m. - 5 p.m.

Insurance Coverage: Provide a copy of a current Certification of Liability Insurance naming J Bar J Youth Services as additional insured.

Food Vendor License: Provide a current Food Vendor License.

Bar Service Vendor: Provide a current license, insurance and approved OLCC application

Promotions, Marketing, & Advertising: Promote your business and support at-risk youth with a sponsorship through cash, gift certificates, or product donation for horse show prizes and awards. Sponsor benefits include promotion through ring announcements, the opportunity to add items to the trainer bags, and flyers in the show office.

Advertising in our Prize List - list of classes & events distributed digitally to all exhibitors; or our Show Guide - publication available during the event and distributed in local media publications prior to the show. Please mark the appropriate box on the application if you wish to receive further information regarding any of these areas.

Your business will be listed on the Vendors page on the OHDC website with a link back to your website.
